Payment Policies

- 1) There will be an annual registration fee of \$25.00 due for each student.
- 2) Tuition is due and payable on or before the first day of class for each session (fall, winter, spring). If tuition is late, a student will be unable to participate, and a late fee of \$15 will be assessed. Once the balance due is paid, a student will be able to dance.
- 3) Tuition will not be pro-rated, credited or refunded for any missed classes. Make-up classes may be taken by calling ahead for approval, and then attending another class of a similar age and level. Make-up classes must be taken within the session in which the enrolled class was missed.
- 4) There will be a \$25.00 fee for any returned checks.

Studio Etiquette

- 1) No eating, drinking or gum chewing is allowed during class time. Water is the only beverage allowed in the dance studio.
- 2) Students must be punctual for class, or they will not be allowed to participate.
- 3) Respect for everyone is expected at all times. NO negativity. Be a good role model.
- 4) Students are required to arrive and be picked up from class on time. *Fancy Feet Dance Studio will charge a late fee if a parent is consistently late picking up.*
- 5) Please call to inform Fancy Feet when you will be absent. Students with excessive absences will lose their enrollment in class, or will be put on probation in the Performance Group. (see P-Group contract)
- 6) Teachers reserve the right to refuse admittance to anyone.
- 7) Teachers will determine the proper placement for each student. Promotion to any level is not automatic.
- 8) Proper dance attire (fitted exercise clothing) and dance shoes must be worn by each student to participate in class.
- 9) Classroom instruction, discipline, or corrections should be handled by instructors only, not other students.
- 10) Cell phones are to be used between classes only. They are not allowed in class.

Recital – June 18th, 2011

- 1) Students continuing classes in January will be expected to perform with their class in the annual recital held in June of 2011, and will be held responsible for purchasing their class costume.
- 2) Costumes will be billed along with the Winter Session renewal (mailed home during the December holiday vacation). Costume fees will be \$50.00 per costume, per class. These fees may be paid any time through January 15, 2011.
